UUSC Pacific Partner Gathering

In June of 2022 UUSC convened a regional partner gathering in Pearl Harbour, Serua Fiji. The gathering created space for partners to plan and map out the different projects in impacted communities that needed resourcing. The outcomes from that gathering can be found here.

True to commitments that were made in that gathering, UUSC dispersed the Loss and Damage funds that were made available by the Scottish Government, through the CJRF.

Those funds have reached the communities that requested them and UUSC has continued to support those communities and ensure the reporting processes have been simple and clear.

One year from the gathering in Pacific Harbour, UUSC is now reconvening the network to share updates and learnings and reflect on the process the way our communities have experienced it.

In order to achieve this we have identified 4 main goals for the gathering:

- → Network Strengthening: Be in a space that can support the strengthening of our UUSC partner network. From both strong and fresh partnerships, this will be an opportunity to learn about, and from, each other. Strengthen our foundation and coordinate to allow for collaborative network-wide strategies to build a strong approach to addressing Loss and Damage.
- → Information Sharing: Foster a culture of information sharing, ensuring space is created for updates and report backs and ensuring we honour our feedback loops.
- → Reflect and Evaluate: Look back on the journey of the network so far. Review and celebrate the diversity of projects and the depth of the work and make time to really acknowledge how far we have come and what we have achieved.
- → Design the Future: Re-center on the priorities around Loss and Damage, then formulate strategies to build community resilience, movement power, political alignment and analysis and keep the voices of the communities we serve.
